<b>Employment</b>	Subject to a six-month probationary period with a three and five-month review.
<b>Offer of Employment:</b>	Subject to two written references satisfactory to Age UK Leicester Shire & Rutland at the interview stage, candidates may be requested to agree to telephone references being obtained.
<b>Disclosure of Record:</b>	<p>The successful applicant is required to apply to the Disclosure Barring Service (DBS) and any offer of employment will be subject to receipt of a satisfactory Enhanced Disclosure certificate.</p> <p>The organisation reserves the right to recover the full cost of an Enhanced DBS (currently £53 plus VAT) should an employee leave their employment before the end of the six month probationary period.</p>
<b>Base</b>	The postholder will be based at Age UK Leicester Shire & Rutland ( <b>Cost Centre No 422</b> ) Gloucester House, 3 Norman Way, Melton Mowbray, Leicestershire, LE13 1JE Age UK Leicester Shire & Rutland reserves the right to change your place of employment to any other designated site within Leicestershire.
