

WAYS OF GIVING

***How you can increase
the value of your gift by as much as 25% ...
... without it costing you a penny more!***

When you choose to make a Gift Aid donation you are giving in the most effective way possible as it allows us to reclaim tax on your donation from the Government whether large or small, regular or 'one-off'.

If you are a taxpayer, we can claim back the tax you have already paid on your donation – adding 25p for every £1 you give. This allows us to plan the services and projects to meet the needs of older people in the Community.

So please, if you can, give us your support with a Gift Aid donation – it will allow us to do so much more for older people who desperately need our help.

You will find two forms attached to this document,

1. A Gift Aid Declaration Form. You should complete this form if you want to allow us to claim back the tax on your donation(s). Whether this is a one off cheque payment or you are setting up a regular direct debit donation.
2. A Direct Debit Donation form – You should complete this form if you would like to donate a regular amount each month, quarter or year direct from your bank account.

NOTES

If your declaration covers donations you may make in the future:

- please notify the charity if you change your name or address while the declaration is still in force
- you can cancel the declaration at any time by notifying us - it will then not apply to donations you make on or after the date of cancellation or such later date as you specify
- if you are unsure whether your donations qualify for Gift Aid tax relief, ask the charity. Or you can ask your local tax office for leaflet IR113 *Gift Aid*
