# Our place in the Age UK Network

# Age UK Cambridgeshire and Peterborough is an independent charity supporting local older people

There are nearly 120 Age UK partners working together as a Network. This does not detract from our autonomy or local focus, instead strengthens the commitment to ensuring older people are valued and heard, whilst enabling us to share best practice, create efficiencies and promote our trusted brand.

Around 100 staff and 350 volunteers are committed to delivering a wide range of tailored services to meet the needs of local older people and communities.

### Our principles - (shared by all Age UK Partners)

The underpinning ways in which we will work to deliver our Mission and have agreed to and support as a Network partner.

Older People First Principle	Always putting the rights and needs of older people first
Values Principle	Always upholding and promoting our values
The Integrity Principle	Transparency, integrity and good faith
The Compliance Principle	Uncompromised compliance with the law and regulatory standards
The Equality, Diversity and Inclusion (EDI) Principle	Promotion of Equality, Diversity and Inclusion

Each of these Principles is important to us as both an independent charity, supporting older people across Cambridgeshire and Peterborough, and as a Partner in the Age UK Network.



# Local perspective

Forecasts are suggesting that the population of over 65s in Cambridgeshire will increase 27% by 2031. Furthermore, it is predicted that the greatest growth will be within the 80 – 84 and 85+ age bands with a forecast growth of 45% and 55% respectively (source JSNA 2023).

In Peterborough it is predicted there will be a 24% increase in those aged 65 and over between 2021 and 2031; the greatest growth is expected to be by 45% within the 80 to 84 age group.

According the 2021 Census, 60% of older adults, aged 65 and over, in Cambridgeshire and Peterborough reported that they were in 'very good' or 'good' general health. However around 1 in 10, or 11%, reported being in 'bad' or 'very bad' health. Fenland and Peterborough areas had higher proportions of adults in 'bad' or 'very bad' health. This may be due to a range of factors, which includes higher rates of deprivation in such areas.

On average life expectancy in Cambridgeshire and Peterborough is either the same or slightly higher than the national average, except for women in the Peterborough area which is significantly less than the national average.





# Challenges faced by older people

Being older is the opportunity, in many cases, to enjoy well-earned time exploring the world, spending time with loved ones, learning new skills and hobbies, whilst utilising and sharing skills that have been put to practice over many years. Sadly, for some it can be a difficult time with individuals experiencing, for example, isolation, poor health, financial and housing worries, which mean being older is not the experience that we would all wish for.

We know from a local perspective, recognising the significant geographical differences across Cambridgeshire and Peterborough, and from our extensive experience supporting older people, that many face challenges with everyday aspects of life, so we make it our priority to offer tailored services and support giving confidence to ask for help when it's most needed.





# **Our charity**

### Challenges to the organisation

As an organisation we recognise the immediate and potential future challenges we face. As a charity we continue to deal with the impact of economic and societal shifts, particularly the impact of the cost-of-living crisis, which currently offers no respite and naturally this brings cost increases to charity operations.

With recent significant increases to the Employers' National Insurance contributions, we face further increasing costs. Equally providing donations to the third sector becomes more difficult for organisations and individuals, even though the appetite to do so is there.

With the expected rise in older population, we know that demand for support and services will also continue to increase. We have extensive experience in providing services which enable timely support for individuals, thus alleviating some of the pressures our statutory partners face, however it is imperative that the value of such provisions is recognised and suitably resourced. We know in doing so the return and savings outweigh initial financial commitment.

We are mindful that local authorities in two tier areas have been invited to submit unitary proposals. Additionally, Integrated Care Boards are under pressure to make cost savings; this and Local Government Reorganisation may bring opportunities; however, we face the uncertainty around commissioning of services and therefore it is imperative to be abreast of the proposals through each stage of the processes.

To enable older people to enjoy later life, by reaching them earlier to access support, providing services specific to their health and wellbeing needs and being their voice on matters of importance.

# **Our Values**

Our values, which underlie the way we operate, are to be Compassionate, Collaborative and Committed. These values guide our defined expected behaviours to ensure that everybody works in unison, believing in our cause and all the individuals and elements associated with it.

Enabling long and short term use of services and provisions, improving confidence, wellbeing and reducing isolation.

- Delivering consistently high quality, person-centred, safe and reliable services.
- Ensuring easy navigation and access to help and support older people and their loved ones or carers and be the provider of choice.
- By providing a welcoming, impartial approach, giving people confidence to seek support.
- Continually developing, enhancing and introducing services which are the preferred choice and most beneficial to local older people.

Age UK Cambridgeshire and Peterborough will achieve this by:

# 2. Promote Independence

Ensuring older people maintain and where appropriate regain levels of independence for as long as possible.

- Reaching more older people, including those in minoritised groups, with quality information about access to health services, care and housing options.
- Continually developing our offering of effective services, allowing people to stay in their own homes for longer and supporting them to be more independent, promoting wellbeing and social inclusion whilst reducing and delaying the need for more intensive statutory services.
- Commitment to lobbying and enabling digital inclusion and seeking innovative and alternative ways to access all digital processes and functions.

2. Promote Independence (cont)

Ensuring older people maintain and where appropriate regain levels of independence for as long as possible.

- Building on our existing relationships in the health and social care sectors to facilitate greater collaboration in promoting independence.
- Regularly promoting the importance of self-help and activity on health and wellbeing. Developing innovative approaches to increasing physical activity, reducing frailty and preventing falls.
- Contributing to local strategic objectives to reduce the number of falls and accidents in the homes of older people.

### 3. Reducing Poverty

Ensuring older people have enough income to live well.

- Working with all sectors to alleviate the pressures felt by those in poverty or at risk of being in poverty.

- Giving confidence to those who may feel embarrassed to ask for such help.

- Encouraging older people to speak up and have their say on all things important to their lives.
- Providing platforms and opportunities to amplify the voice of older people, whether by older people themselves or on their behalf.
