MESSAGE FROM THE CHIEF EXECUTIVE FOR THE YEAR ENDED 31 March 2018

This year has been a successful year, as we have consolidated our services to ensure that the charity more sustainable going forwards, whilst continuing to provide vital support to thousands of older people. Our Dementia Support Service, renamed the 'New Horizons Club' celebrated its first full year of operation and now operates at capacity, providing a vitally important service to those living with dementia as well as those who care for them. Our Help at Home service continues to provide valuable support to older people in their homes across our area, and our Information and the Advice service has again handled many thousands of queries from older people, their carers, families and friends about issues that impact on older people in later life.

In addition to our core services, our Men in Sheds project has continued to operate, despite lack of external funding. A welcome addition to our service offering this year was the Joining Forces project, an exciting new initiative aimed at supporting and improving the wellbeing of aged veterans. The project, although still in its infancy, has already achieved some notable successes, and constructive relationships have started to be developed across the plethora of veteran support organisations and charities. In addition to these main services, we also operate a computer learning group and an art group, both volunteer led, with classes specifically aimed at older people.

All this has been achieved against a continued difficult financial environment, which has been compounded by commissioned services being terminated early or not recommissioned. The Charity's Board of Trustees has long been aware of this scenario and very wisely invested in the charity's capacity to raise its own unrestricted income, which is achieved through its six high street shops. Although the retail environment itself comes under increasing pressures, the shops have still managed to make a contribution to the charity, which is vital for our wider services.

None of this would have been possible without the amazing contribution of our staff and volunteers, who have continued to provide first class services against a very challenging backdrop. This has, of course, been made easier in the knowledge that all of that effort has enabled us to provide so much important support to older people across Cheshire East.

REPORT OF THE TRUSTEES FOR THE YEAR ENDED 31 March 2018

Introduction

The directors and trustees of Age Concern East Cheshire (a Company Limited by Guarantee) present their annual report for the year ended 31 March 2018 under the Companies Act 2006 and the Charities Act 2011, together with the audited financial statements for that year. The financial statements comply with the Companies Act 2006, the Charities Governing Document and the relevant Statement of Recommended Practice (the Charities SORP (FRS 102)).

Reference and Administrative Details

Age Concern East Cheshire is a registered charity (No.1090161) and a company (No. 4309557) limited by membership guarantees. Its registered office is shown on page 1.

The trustees who served during the year, together with details of external advisers, are noted on page 1.

Structure, Governance and Management

. Governing Document

The charity is governed by its Articles of Association adopted on 19 October 2001, updated 29th November 2012 and 8th December 2015

Age Concern East Cheshire is an independent registered charity and a member of the Age England Association. The Age England Association is an association of autonomous registered charities.

Age Concern East Cheshire, under its working name, Age UK Cheshire East (AUKCE) by which will be referred to within this report, continues to be an independent registered charity with an area of benefit that mirrors the unitary authority boundary of Cheshire East.

Governing Bodies

The Board of Trustees is responsible for the overall governance of the charity.

· Recruitment and Training of Trustees

The trustees are responsible for the appointment of new trustees. New trustees will only be appointed after due consideration is given to eligibility, personal competence and specialist skills. New trustees, when appointed, are inducted into the working of the charity by the existing trustees and the Chief Executive.

Risk Management

The trustees have assessed the major risks to which the charity is exposed, in particular those relating to the operations and finance of the charity, and are satisfied that systems are in place to mitigate the exposure to major risk.

Public Benefit, Aims and Intended Impact

The object for which the charity is established is to promote and enhance the quality of life and well-being for all members of the public, with a particular focus on those aged 50 years and older. This may be undertaken in any manner which now or hereafter may be deemed by law to be charitable, mainly but not exclusively in Cheshire East.

The charity which was established in 1988 has as its mission:


"Improving later life for people in Cheshire East"

Age UK Cheshire East is recognised for its provision of quality services, its campaigning with and on behalf of older people, its reliable, up-to-date information and advice and as a pioneer of innovative services. Age UK Cheshire East has discussed needs and developmental issues with older people, their carers and families and with volunteers and staff. The external environment and plans of local statutory and voluntary organisations have also been taken into account.

The charity considers it important to take account of older people's needs and aspirations in deciding its strategic aims and direction. It also considers it important to take account of the wider external environment and potential sources of funding for the charity's work.

The charity is structured around what Age UK Cheshire East believes are the four vital elements to an independent later life.

Practical help



We have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing our aims and objectives and in planning our future activities. In particular the trustees consider how planned activities will contribute to the aims and objectives they have set.

Financial Review

A summary of the year's results can be found on page 14 of the attached accounts.

During the year, the total incoming resources were:
Unrestricted £1,058,324, Restricted £188,187 Total £1,246,511 (2017 £1,566,084)
Total resources expended in the year were £1,246,965 (2017 £1,778,622). At the balance sheet date the free reserves of the Charity were £172,673 (2017 £151,914). Other reserves tied up in fixed assets and restricted funds were £209,494 (2017 £230,707)

Reserves Policy

The reserves fund represents the unrestricted funds arising from past operating results and from the free reserves of the charitable company. This is intended to protect the charity from the risk of disruption to services at short notice due to lack of funds, while at the same time ensuring the organisation can continue to operate as normal. In the opinion of the trustees, as at 31 March 2018 free reserves were 50% of the prudent level of reserves.

Investment Policies

Under the Articles of Association, the charity has the power to make any investments which the trustees see fit. The charity has a policy of keeping any surplus funds in short term deposits, which can be accessed readily. All funds are invested at the bank and the trustees consider their return on the investments throughout the year to be satisfactory.

Review of Development, Activities and Achievements during the Year

Social Accounting

By applying social accounting principles to our work over the last year, we can demonstrate the following impact:

Social Impact

Age UK Cheshire East offers a variety of services, providing direct help to thousands of individuals each year. The detailed impact of individual services, and their outcomes, is provided in the following pages.

Economic Impact

Income attracted to the local area:

In the last year we secured £110,484 funding from outside Cheshire East for the benefit of local older people.

Volunteer hours:

Around 150 volunteers support our services within Age UK Cheshire East. Over the year we have calculated that volunteers have given us **29,434** hours of their time.

Based on the average income (2017) for Cheshire of £15.55 per hour (source ONS Annual Survey of Hours and Earnings), this represents a monetary value of around £458,000

Income maximisation:

Total income gains of £1,180,173 were claimed on behalf of older people in the last year. Cheshire East Council estimates that for every pound in benefit claimed, 78p is spent locally, equivalent to £920,535 for the local economy.

Environmental Impact

The organisation's 5 Charity Shops and Furniture Showroom act as town centre recycling points for clothes, furniture, books, bric-a-brac and electrical items.

Information and Advice

Our Information and advice service provides up to date information on a wide range of issues such as housing, health and care, money matters, leisure and social opportunities. As well as meeting clients in the offices in Macclesfield, home visits can also be offered.

During the year, the service has dealt with 6,450 enquiries from 4,411 individuals. Clients raised 10,062 issues with our advisers and volunteers, with the main issues being benefits, non-residential/domicillary care and residential care. As well as providing such information, the service also helps older people complete forms and offers specialist advice sessions on issues such as wills and related legal matters. Alongside our adviser, 6 volunteers have provided an invaluable 411 hours of additional support.

The largest percentage of queries relate to benefit issues. During 2017/18, there were 1,769 benefit checks undertaken with the annual income gain for our clients as a result of this support totalling £1,180,173.

To ensure that the service we provide remains relevant, we survey our service users after they have received a service from us by satisfaction surveys by post and carer feedback by telephone.

We were grateful to the Big Lottery Fund who funded the service until December 2017, after which the service was funded by Awards for All.

iACE Information & Advice

iACE is a service commissioned by Cheshire East Council, which provides easy access to accurate, relevant information and advice which enables people to understand their options relating to; all aspects of care and support, health and disability conditions, resolving issues, making choices and accessing services.

The service is for anyone who has queries about adult social care issues including people with illnesses and disabilities, carers and young people in transition from children's to adult services.

Issues we can help with include:

- The Care Act
- · Peer social support and leisure activities
- · Accessing care and support services
- · Paying for Personal Care
- · Condition specific information
- · Adaptive technologies and independent living aids

The iACE service is provided in a consortium of local, quality assured, information and advice providers which also includes Citizens Advice Cheshire East, Age UK Cheshire, Disability Information Bureau, Citizens Advice Cheshire North and the Deafness Support Network.

iACE Information & Advice - continued

During the year, the project has dealt with 188 clients on a wide variety of issues, providing 517 interventions.

Due to changing commissioning priorities, Cheshire East Council has terminated this contract with effect from 31 May 2018.

Help at Home

Our Help at Home Service is a vital service providing practical help and support to the over 50s in their homes. Our 25 Home Helps are fully trained and help our clients with a wide range of household tasks, including cleaning and laundry, shopping calls, accompanying service users to appointments and respite/companionship allowing carers a break. A key aspect of the service is that we visit older people in their homes, providing a regular contact point for them and we are able to tailor our support to ensure it best suits their needs. Over the year, an average of 175 service users have accessed the service, receiving a total of 13,946 hours of support in their homes.

New Horizons Club (Dementia Day Support)

2017/18 was the first full year of the Centre's operation, following its opening in September 2016. The centre can cater for up to 14 users every day, and is primarily focused on people with memory problems and experiencing the early stages of dementia. We have an excellent relationship with Cheshire East Council's Dementia Reablement Service, who refer many clients through to us to receive our support.

The service is operated by a small team of dedicated Activity Support Workers, who provide a range of stimulating activities for service users, and if weather permits, an opportunity to go out on trips in the service's very own minibus. To ensure that the service remains accessible to residents across our area of benefit, we provide transport to and from the centre, using a combination of staff and volunteer drivers.

The service is a 'paid for' service and the fees charged cover the provision of the service, with any surplus ploughed back into the charity to further improve services for older people.

At the end of 2017/18, the service had a total of 38 service users. 245 sessions had been held during the year, which was only 3 below target due to the group closing as a result of adverse weather conditions. Over the year, 2790 places were filled, against the target of 2,976. Volunteers provided 2,466 hours of support.

Men in Sheds

This project uses two well stocked sheds built within two locations in Macclesfield and Congleton. The project is a place where older men can be themselves. Those attending the sheds can make use of their skills and experience and share them with other service users, as well as taking part in a number of woodworking projects.

The project enables men to make friends and extend their social networks, in a welcoming and warm environment. Three sessions are held every day, with both sheds open every Monday and Tuesday. In total, there have been 1,194 attendances during the year. In addition, a number of volunteers help to run

the project. We have been grateful for the ongoing support of a number of funders during the last year, which have included Cheshire Community Foundation, The Francis Winham Foundation, The Hobson Charity and Macclesfield Town Council. However, we enter 2018/19 without any external funding and the securing of funds to maintain this project for future years will be a priority.

Joining Forces

This project commenced in July 2017, when we were successful in securing funding from Age UK to run a project along with 12 other areas in England. The project is financed from The Aged Veterans Fund funded by the Chancellor using Libor funds.

The project commenced with initial mapping, networking and relationship development, which proved successful in identifying veteran services already being provided and the range of organisations delivering those services. This initial phase also helped develop some strong strategic and operational relationships to help with positioning the project, developing our knowledge base of veteran specific issues, and influencing. In particular, the project has looked to collect better data around veterans through the organisation of a Cheshire East Joint Strategic Needs Assessment (JSNA) and also the fostering of more joined up services through a Cheshire East Armed Forces Network group.

We have developed promotional materials and managed to create good visibility through events, media and social media. In terms of numbers, we believe our communication has potentially hit over 15,000 people with about 500 aged veterans and 50 families engaging with the message in some way. At the more specific support end, the project has provided guided support to around 20 people to date. Whilst not a huge number, the outcomes have made some quite significant differences to people's lives.

As the project develops, it will look to use the data from the JSNA to understand the needs of veterans and to develop some more specific services/activities, probably focussing on the setting up of groups and developing befriending. It is also hoped the JSNA will give a clearer view of the number of veterans out there in order to review our target numbers. We have reviewed our marketing and communication activity and plan to use a radio campaign along with improved social media activity to engage with veterans and perhaps more significantly, families' friends and carers.

ICT Learning

We recognise the added value that computer literacy can bring to the lives of older people, and in particular, help address the issues of social isolation and enable people to lead more independent lives.

The ICT learning project provides learning and support for older people to respond to these very issues. The sessions are delivered through our learning centre in Henderson Street. Group sessions' led by volunteers, offer support and advice for those with particular issues or the use of equipment for those wishing to gain confidence knowing that a mentor on hand if they have a problem.

Individual courses are available for those who perhaps feel uncomfortable in a group environment and for complete beginners who need individual attention.

There is continuing change in client requirements from starters and absolute beginners to people who need help progressing to updated operating systems and equipment. Existing users often seek help the project.

ICT Learning - continued

We have been grateful for the ongoing support of a number of funders during the last year, which have included HSBC, The Royal British Legion, The Pennycress Trust, The Leigh Trust, Cheshire Community changing from traditional desktops and laptops to using tablets and phones. We make a small charge for sessions to make a contribution to costs.

Art Group

Our art group meets every Thursday in Macclesfield, clients of all level of experience can learn new skills and keep active. The group enables everyone to make friends and extend their social network, in a welcoming and warm environment. All equipment is provided and clients make a small contribution. Each year, the group hosts an art exhibition to show their work.

Long Term Care Discharge Placement

This service, which terminated in June 2017, was funded by Cheshire East Council, supporting people in hospital who have been assessed as requiring discharge into long-term care. During the first three months of the year, the service received 73 referrals, providing local knowledge in relation to all aspects of choosing and funding long-term care, with the aim of helping those older people select a care home most appropriate for their wishes and needs.

Charity Shops

The Charity has five high street shops, together with a furniture showroom. The shops, located in Alderley Edge, Congleton, Knutsford, Macclesfield and Poynton, sell a wide variety of good quality second hand clothes, books, DVDs, CDs, toys, jewellery, watches, electrical goods and various items of bric-a-brac. The furniture showroom, based across the road from the charity's offices in Henderson Street, Macclesfield, sells a large amount of quality second hand furniture, including beds, wardrobes, tables, chairs, sofas and pictures.

The charity is extremely grateful to the 100+ volunteers who help the staff make the shops such a success, as well as the customers who continue to use our stores and also donate unwanted goods, which in turn bring in vital unrestricted income to support the charity to provide a wide range of services for older people.

Trading

For a number of years, Age UK Cheshire East has worked in conjunction with Age UK to sell insurance and other related products. Changes in the arrangements have meant that Age UK Cheshire East has ceased the trading of these products with effect from 8 March 2018.

Volunteers

We are supported by approximately 150 volunteers, who undertake a variety of roles across the charity, including supporting our shop staff with a wide variety of tasks; providing support to people living with dementia, organising art groups, or providing information and advice on a wide variety of issues. Without their valuable support, we would not be able to provide the level of services that we do, and we are very grateful for all their efforts on behalf of our charity.

Opinion

We have audited the financial statements of Age Concern East Cheshire (the 'charity') for the year ended 31 March 2018 which comprise the statement of financial activities, the balance sheet, the statement of cash flows and the notes to the financial statements, including a summary of significant accounting policies. NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 March 2018

1. Accounting Policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year and in the preceding year.

(a) Basis of Accounting

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and the Republic of Ireland (charities SORP FRS 102) and the Companies Act 2006. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy notes.

(b) Fund Accounting

Unrestricted funds are donations and other incoming resources receivable or generated for the objects of the charity without further specified purpose and are available as general funds.

Designated funds are unrestricted funds earmarked by the trustees for particular purposes.

Restricted funds are funds that are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular purposes. The aim and use of each restricted fund is set out in the notes to the accounts.

(c) Group Financial Statements

The financial statements consolidate the results of the charity and its wholly owned subsidiary, Age Concern East Cheshire (Enterprises Limited), on a line-by-line basis. A separate Statement of Financial Activities, and income and expenditure account for the charity has not been presented because the charity has taken advantage of the exemption afforded by section 408 of the Companies Act 2006.

(d) Incoming Resources

All incoming resources are included in the Statement of Financial Activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

- Voluntary income is received by way of grants, donations and gifts and is included in full in the
 Statement of Financial Activities when receivable. Grants, where entitlement is not conditional on
 the delivery of a specific performance by the charity, are recognised when the charity becomes
 unconditionally entitled to the grant. For legacies, entitlement is established once the charity has
 been notified of an impending distribution.
- Donated services and facilities are included at the value to the charity where this can be quantified. The value of services provided by volunteers has not been included in these accounts.
- Clothing and other items donated for resale through the charity's shop are included as incoming resources within activities for generating funds when they are sold.
- · Investment income is included when receivable.
- · Incoming resources from charitable trading activity are accounted for when earned.
- Incoming resources from grants, where related to performance and specific deliverables, are
 accounted for as the charity earns the right to consideration by its performance.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 March 2018 (Continued)

1. Accounting Policies - continued

(e) Resources expended

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates.

Where central costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of the resources following a high, medium and low usage, with charity shops covering the remaining balance. Breakdown as follows:

(f) Depreciation

(g) Stocks

Stocks are valued at the lower of cost and net realisable value. Cost is determined on a "first in, first out" basis and net realisable value is determined on the basis of expected selling price less any further costs expected to be incurred to disposal. Donated goods for sale in the shop are not valued for inclusion in the stock, sale proceeds are accounted for in the year in which the sale occurs.

(h) Pension Contributions

The charity operates a defined contribution pension scheme, the assets of which are held separately from those of the charity in independently administered funds. Contributions payable for the year are charged in the statement of financial activities.

(i) Operating Lease Commitments

Operating leases and payments made under them are charged to the Statement of Financial Activities on a straight line basis over the lease term.

(j) Net Income from Trading Activities of Subsidiary

The wholly owned subsidiary, Age Concern East Cheshire (Enterprises) Limited, provides insurance and related financial product services. See note 17 for a summary of the results.

The Information and Advice Service was funded from the Big Lottery through the Reaching Communities Fund until 31st December 2017. The service is based at the New Horizons Centre (NHC) in Macclesfield, with limited home visits also provided, with the purpose of increasing access to information and advice by older people and their carers. The service provides information, advice and casework on a wide range of issues, and helps older people and their carers to increase their income through benefit claims and grants, e.g. for home improvement.

The iACE project is run in partnership by 6 organisations, with Cheshire East CAB acting as the lead organisation, funded by Cheshire East Council.

The LifeLinks project ran in partnership with Peaks and Plains until 2nd April 2017 and was funded by Cheshire East Council.

The MOD project run in partnership with Age UK and other local Age UK's, funded by Ministry of Defence.

Age Concern East Cheshire has received resources from Trust Funds during the course of the year. Of the £38,994 received, £24,550 was spent during the year, with the balance of £14,344 deferred until 2018/19.
