5 Chief Executive Service Review

Chief Executive Officer, Robyn Holmes noted that this year's annual report was in a new format and gave a presentation to expand on the figures shown in the report.

- Although the covid crisis is not as severe, Age UK County Durham continues to
 experience its impact and is responding and adapting its services to expand its reach in
 the County. Plans are being development to provide more services in Teesdale and
 Weardale and to engage with those aged between 50-65 as well as maintaining the
 support from those aged 65+.
- The information and advice service supported clients in claiming £3,482,850 in unclaimed benefits during 2021-22
- Mental health and wellbeing services are still very much in need, AUKCD supported 639 clients during and the work is continuing
- Dementia sessions, funded by the Age UK national charity, have been a great success and this work is being developed to provide day sessions at Bishop Auckland College from November 2022 onwards
- The Falls Prevention pilot set in extra care settings has been a huge difference to the confidence of those taking part
- The Help at Home project has helped 405 clients with shopping, gardening and small DIY tasks
- The intergenerational work is being embedded into all our work
- Activities are still very popular with 1123 taking part in a variety of exercise groups
- The Bike Loan scheme was supported by an amazing volunteer who made sure all the bikes for loan were checked and maintained, this is no longer running and the bikes have been moved to our Superstore

Robyn Holmes thanked the trustees for their guidance and support. She is very proud of the staff team who have been very responsive and willing to adapt to new requirements and roles when needed. Age UK County Durham's work could not continue and grow without the help and support from all its volunteers, they are integral to all the work we do.

The support from funders and partnership working is also invaluable and of great benefit to the organisation.

6 Presentation of Annual Report and Accounts

David Holloway from Ribchesters Chartered Accountants was pleased to report that Age UK County Durham was in a financially sound position at the end of March 2022. Income generated in 2021-22 totalled £1.072million which included an increase in retail sales and successful funding grants from new funding streams. Expenditure was £882K - 88% of income generated was spent on direct delivery.

Lisa McCallum, Finance Manager, thanked Ribchesters for their audited accounts.

7 Review of auditors

Auditors are appointed on a three-year cycle. Ribchesters Chartered Accountants (a locally based company) have completed one year as the organisation's auditors and it was proposed that they continue for a further two years. This was agreed by all members
