

Terms & Conditions

Public Liability Insurance - Each stallholder MUST have public liability insurance. We will require a copy of the Certificate with the completed application form.

Food Hygiene Rating Certificate - We will also need to see a copy of the food hygiene rating for food / catering stalls. If it is not possible to verify this online then you will need to provide us with a paper copy.

Temporary Event Notice - Any stallholder selling alcohol will need to apply for a TEMPORARY EVENT NOTICE from Rother District Council and a copy of the confirmation must be sent to us prior to the event.

Risk Assessment - We also require that you carry out a full risk assessment in relation to the event and a copy of this must be included with your completed application

If any of these documents are not provided to us prior to the start date of the event we will be unable to provide you with access to the event and your fee will be forfeited.

- Whilst the charity is the ultimate organiser of the event, and therefore holds ultimate responsibility, the event is being operated and run by a committee of volunteers on behalf of the charity.
- This committee is overseen and managed by the Events Coordinator and Head of Fundraising and Marketing but the committee has delegated powers of decision making and operation in relation to this event.
- To keep a fair balance across the types of stalls, the committee reserves the right to close
 applications from certain stall types depending on the quantity received. You will be advised in
 good time after we receive your form if we are unable to provide you with a stall.
- The deadline for payment, application forms and additional paperwork is Friday 26th April 2019.
- Applications will be processed in order of receipt.
- If payment is not received by the set deadline, the pitch will be reallocated. Your pitch is only finally guaranteed once the payment is received.
- It will not be possible to follow up with you for your application form / insurance / payment. This
 will be your responsibility. The charity cannot accept responsibility for those applications which
 are not received.
- The pitch fee is NON-REFUNDABLE in any circumstances.
- Electricity is not available at all sites.
- The committee is not responsible for any adverse weather conditions, please be prepared for all
 eventualities. We cannot be responsible for the loss of earnings or inability to trade or any
 damage to stock/equipment.
- The event will run from 10am -5pm. Details regarding set up times will follow. In order to keep the
 event a success however it is requested that stall holders do not pack up before the end unless a
 decision is advised by a committee member.
- We reserve the right to change any of the above conditions.
