# **Independent Care Act Advocacy**

Following the introduction of the 2014 Care Act, Local Authorities now have a legal duty to offer access to independent Advocacy to anyone engaging in adult social care processes who is struggling to understand or retain information or to communicate their own views and wishes.

The Local Authority must arrange an independent advocate to facilitate:

- The involvement of a person in their assessments
- · Preparation and review of their care and support plans
- Support throughout safeguarding adult enquiries and reviews under the Care Act 2014

This applies if the Local Authority considers that the person would experience **substantial difficulty** in understanding the processes or in communicating their views, wishes or feelings and there is no **appropriate individual** to help them.

The legal duty applies in all settings including in the community, care homes or prisons.

#### What do advocates do?

- · Offer a free, independent service
- Help you to access and understand information
- Give you time and space to consider your options
- · Defend and promote your rights and responsibilities
- · Respect your decisions

#### What don't advocates do?

- Make choices for you
- Give legal advice
- Provide Personal Assistant services
- Provide emergency support

# Who is Independent Care Act Advocacy for?

The service is available to anyone living in Leicester City and the counties of Leicestershire and Rutland for:

- Adults
- · Young people going through transitions
- Care leavers
- Carers
- Young carers
- · Prisoners currently detained in the area

who are subject to Social Care processes and are struggling to engage with or understand the process.

#### How can I access the service?

We do expect that the majority of referrals will come to us directly from Adult Social Care. If however, you or someone you know is undergoing a Social Care process (e.g. Assessment or Review) and is struggling to engage with that process and has not already been referred for Independent Advocacy Support you can contact us by telephone, fax, email or post details of which are on the front of this leaflet
