We would recommend further research on the effects of poor air quality on older Londoners in particular. To our knowledge there may be a lack of academically robust evidence on this question with much existing research focussing on children and younger people. We have received some feedback from older people that they are aware of poor air quality having harmful effects on themselves and/or other older people.

In addition to residents and disabled tax class vehicles, we would like to ask for consideration of a sunset period for vehicles such as minibuses operated by charities and similar organisations providing front-line services to disadvantaged Londoners.
