Age UK Tameside (AUKT) was first established in 1974 as a federated member of Age Concern. In 1999 with the support of a national lottery capital grant the Charity moved to 131 Katherine Street where we deliver a dedicated community service to older people across the borough.

We are an Independent Age UK and part of the wider Age UK network with over 120 Age UK charities delivering local services across communities in the UK.

We are funded through a combination of local authority commissions, grants, trusts, donations, as well as other enterprises.

Trustee Role Summary:

Age UK Tameside Trustees have a collective responsibility in making sure that the Charity achieves its core purpose. Trustees oversee the overall governance and administration of the Charity. They also ensure that the Charity has a clear strategy and that the work of the Charity centres around the needs of older people living in Tameside and is delivered to the highest standards of quality and care in line with the Charity's values.

Tasks and Actions:

- To approve strategic plans, operational plans as well as monitor and evaluate their implementation.
- To ensure robust policy and procedures are in place, reviewed and monitored to ensure the Charity operates safely and within the law.
- To ensure the Charity meets its contract specifications, outcomes, targets and KPI's.
- To oversee financial plans, budgets and monitor to evaluate progress.
- To ensure the Charity discharges its legal obligations as an employer.
- To ensure risks are identified, monitored, and controlled effectively.
- To review and approve financial statements.
- To provide support and challenge to Charity CEO whilst undertaking their delegated authority.
- To undertake sound decisions on behalf of the Charity in line with their governing authority.

The Board of Trustees meet 3 times a year and attend and annual planning event with the CEO and Exception Reports are also provided to the Board each month.
