## Job purpose:

Age UK Waltham Forest is developing a range of high quality, paid-for services to ensure older people can have a safer time in their own home. Your role will be to deliver a Nail Care Service, beginning at three sheltered housing schemes. The role involves an initial assessment to ensure the service is suitable for the individual. Following this you will provide toenail cutting and simple enhancements, such as the removal of dry skin, and promoting good foot health by giving advice on self-management to help keep feet in a healthy condition.

## Key Responsibilities.

- To receive referrals from the services manager with appointment slots.
- To do a preliminary check with the client on their first visit to confirm their suitability, and update information on each subsequent visit.
- To cut clients' toenails at appropriate intervals (approximately every 6 weeks) in treatment rooms in sheltered housing venues.
- To record fully any foot care and health problems and highlight any concerns about foot health or general health to their GP.
- To ensure that the clients' own nail care kits are in good condition.
- Report all incidents, accidents and concerns promptly to the Service Manager.
- To maintain clear and accurate records of each treatment with clients.
- To ensure an adequate supply of the necessary materials, including PPE, in each treatment room.
- Risk assess working environments as appropriate in line with overall Risk Assessment Policy and carry out work in line with the organisation's Health & Safety policy.
- To support and coordinate with the volunteer assisting the service.
- Make referrals/signpost to Age UK Waltham Forest colleagues and other appropriate agencies and organisations for specialist support
- Attend meetings and events relating to the project as required
- Commit to and undertake any necessary training sessions to extend and update own knowledge
